




BUSINESS SIMULATION

In the following pages, you will find assignments that we will complete primarily in class. You will be in a group with three or four other students who sit near you in the class. This will be your team for the semester and this will facilitate completing the work during class time as we apply the concepts from the course to real-life scenarios. However, there will be times you may need to work outside class to complete them.

My recommendation is that you upload this document as a Google doc that all team members can access and work on. You will have the opportunity before the end of the semester to let me know if all team members contributed to the product.
